D. Committee Action Plans for 2023-2023 Academic Year

- Communications, Networking & Social Media Rosalyn Walker & Renee Parker
 Renee provided the following updates.
 - 1) Rosalyn submitted two requests for presenters for the February 6th Council meeting. Dr. Ted Mitchell, ACE President topic of the, 88th Legislation Takeaways and Dr. Helen You, Texas Demographic Center. Jean asked Lisa and Christine to continue to work with their committee on a teach and school leadership marketing campaign to provide an awareness of education as a career opportunity.
